9. MANAGEMENT REPORT(S)

a. Leadership Monthly Report:

Clayton: transition to optional masking went very smoothly. Staff intent to return forms have gone out and they have received most back. They are onto second round interviews for the school counselor position. Conferences just finished, with both remote and in person offered to parents. Scheduling for the M-Step is underway.

10. BUSINESS

a. Michigan Charter Schools Grant Report

Davis: the request for the Charter School Grant round three has now been submitted, and we are awaiting approval from the MDE. There are still a few items pending on round two, and those will need to be wrapped up before we can move forward with round three.

b. Monthly Financial Report - February

Davis reviewed the report: OMPS' financial picture looks very good, including having two months of cash in the bank. P&L comparison was reviewed: OMPS is at 66% of the fiscal year and revenues and expenditures are matched well, except for the expected lagging salary line based on timing of those expenditures, and remaining the technology expense from the grant that is still pending.

c. Amended 2021-2022 General Operating Budget

Davis reviewed the details of the budget amendment including noting the increase to income due to ESSER grant funding as well as the increase in the projected addition to fund balance. Davis reminded the board that the fund balance will be needed in future years when there is no longer grant funding, which has provided a great deal of support for OMPS in the last few years.
