

Amendment #1 to Operating Budget Resolution Fiscal year July 1, 2020 to June 30, 2021

Resolved, that this resolution shall be the general appropriations of Old Mission Peninsula School for the 2020-2021 fiscal year; a resolution to make appropriations; to provide for the expenditure of the appropriations; and to provide for the disposition of all revenue received by Old Mission Peninsula School.

Be it further resolved, that the total revenues and unappropriated fund balance estimated to be available for appropriation in the general fund of the Academy for the fiscal year 2020-2021 are as follows:
